3) FREQUANCY OF BOARD METING AND ADVISORY BODY

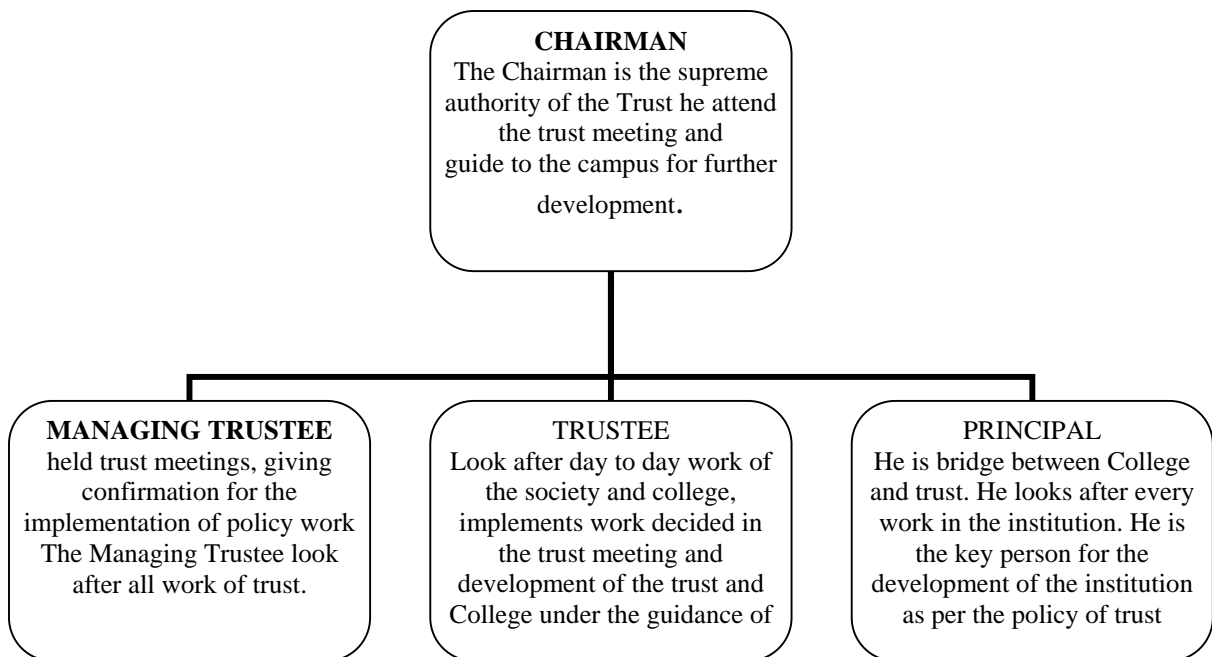
Meeting of board of trustee is held regularly to develop and look after the work of the College and trust activity, in any special condition the meeting of board of trustees meets extra.

M. P. College of Pharmacy has been organized by Jeevanshilp Education Trust, Kapadwanj. The following is the organizational chart and process.

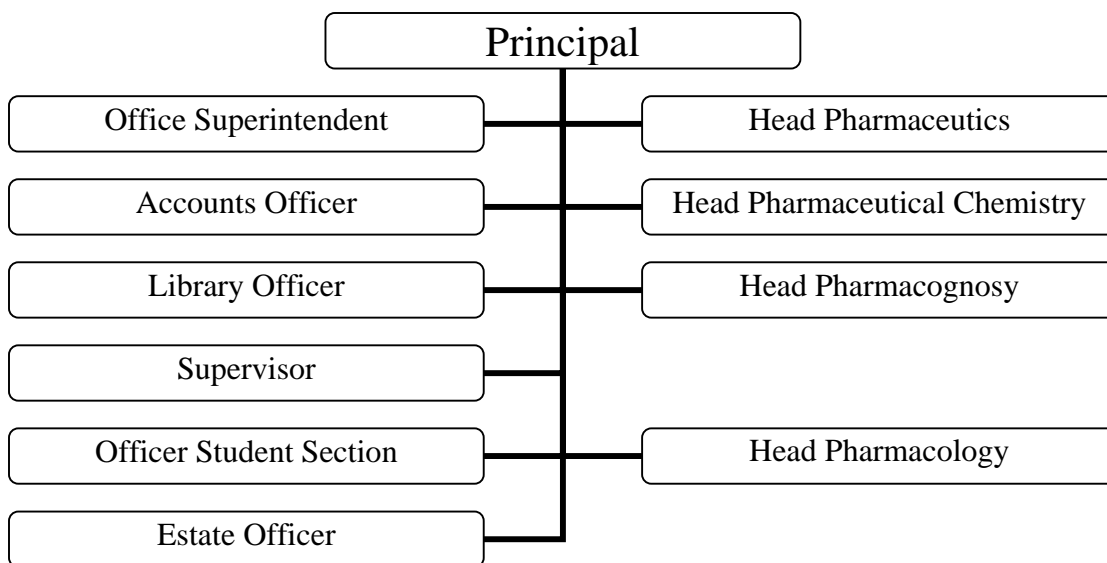
i) ORGANIZATION :
